Jack Martin Court

Jack Martin Court is a 2 unit property originally constructed as accommodation for people with physical disabilities. It was the resultant efforts of the Lower Eyre Peninsula Accommodation for Disabled (LEPAD) group and the Port Lincoln City Council.

One of the two units will now be available for rent to be used as a short term respite facility for eligible residents of the Lower Eyre Peninsula as a joint project between West Coast Home Care, Disability SA and Uniting care Wesley and South Australian Community Housing Authority.

The unit is of modern brick veneer construction on a single level and consists of two large bedrooms, with built in robes, one containing a double bed the other two singles. A large open plan living area containing the kitchen with pantry, full size fridge, microwave oven and other electrical kitchen appliances. All cupboards are low level for easy access.

There is a four seat dining setting and a three-piece sofa and coffee table, a TV, video DVD player. A Washing machine & dryer are provided in an alcove adjacent the kitchen with an open disability friendly bathroom,

All external windows and doors are fitted with security screens.

There is a small fenced outdoor area with single gates opening to the front of the property.

There is undercover off street parking.

The unit is set up to accommodate up to four, but can accommodate up to six using the sofa bed in the lounge.

Persons using the facility will require their own care provider. There is no capacity to provide supervision or carers by the facility.

This is a community based facility, and while not a commercial operation there is a fee structure, this is to help pay for the rent, maintenance, utilities, replacement equipment cleaning etc.

The cost structure will vary slightly dependent on the usage.

Bookings for the unit are essential. Persons making the bookings will be responsible for providing basic information, including: Name and DOB of client, nature of disability, Carer Name, Number of nights, identifying and arranging appropriate supports as well as advising of cancellations and providing basic information required for recording of statistics and the issuing of accounts.
